Pre-Entry Deadlines:

May 21, 2012 for June Show & July 30, 2012 for August
After those dates please enter at the show.

As a courtesy please consider pre-entering.

SWBA would like to make the entry process as smooth as possible for our show secretary and exhibitors. **NO PAYMENT IS REQUIRED with your entries, as payment will be submitted at the show office when you check in upon arrival at the show.**

To pre-enter, your submission must include the following:

- An entry form completely filled out and signed. Must include a phone number or e-mail address.
- A copy of your horse's current 2012 negative coggins test.
- If not already reserved, please reserve yours stalls with Rose Motelet at 608-235-4763 or email her at luckyacresqh@yahoo.com.

ABRA Exhibitors must also include:

- Copy of the front and back of your ABRA membership cards for the owner and exhibitor of the horse.
- Copy of the front and back of your horse's registration papers.
- Copy of ABRA Open Performance Register of Merit (ROM) if entering ABRA Performance Halter.
- Copy of ABRA AM Performance Register of Merit (ROM) if entering ABRA AM Performance Halter.

Upon arrival at the show (assuming you have already pre-entered):

- Check in at the show office.
- Notify show office of any changes in classes, exhibitors, etc.
- Provide an open signed check payable to **SWBA** or pay cash for your entries. Final check amount will be filled in by you when you tab out at the end of the show.
- Show proof of original 2012 negative coggins test. Provide a copy to leave at the office if it was not submitted with your pre-entry.
- Show proof of original current Interstate Health papers for all out-of-state horses. Provide a copy to leave at the office.

ABRA Exhibitors must also show the following items at check in for verification:

- Original or Copy of ABRA membership cards for the owner and exhibitor of the horse.
- Original or Copy of ABRA registration papers.
- Copy of ABRA Open Performance Register of Merit (ROM) if entering ABRA Performance Halter. Provide a copy to leave at the office if it was not submitted with your pre-entry.
- Copy of ABRA AM Performance Register of Merit (ROM) if entering ABRA AM Performance Halter. Provide a copy to leave at the office if it was not submitted with your pre-entry.

Copies of all forms can be downloaded from the website at www.swbuckskin.com. **Stalls must be reserved in advance by calling Rose Motelet at 608-235-4763 or email her at luckyacresqh@yahoo.com.** Keep a copy of your pre-entry for your records. If you are unable to attend we ask that you call or email the show secretary prior to the show.
